**Sub: Centralized Counseling for Admission to the AYUSH UG and PG courses for the academic year 2019-20 – reg.**

Sir/Madam,

I am directed to refer to Ministry's letter dated 18.06.2019 (copy enclosed) and to say that all Heads of the participating Institutions of Round-1 counseling should ensure creation of login Id and Password for their Reporting Officers through their profile (by using create new user option in their profile as detailed in user manual) **on or before 05.07.2019**. As, after declaration of results of different Counseling rounds, Candidate will report to the allotted Institute during reporting period and reporting officer of the college has to Login into his account and has to initiate candidate verification and should check all the relevant documents. For PwD candidates, PwD certificate should be as per the guidelines issued by Central Government and notified by the CCIM/CCH.

2. After verification, if Candidate fulfills the eligibility criteria, then Reporting Officer has to generate admission letter of the Candidate and has to complete the admission process. If candidate fails to fulfill the criteria, then his/her seat will be cancelled. **All head of the Institutions and reporting officers should ensure that no candidate shall be admitted without fulfilling the eligibility criteria.** The reporting period for first round of counseling is from **05.07.2019 to 15.07.2019**.

3. **All institute heads and reporting officers are requested to read FAQs, user manual in details to avoid any mistake and should visit different sections of Counseling website and Institute counseling website time to time for updated information.** Further, detailed manual for reporting will be available soon on website for Institute login.
